



Governing Body Information for the academic year 2017-2018

Structure and Remit of the Governing Body

1. The name of the school is Monksmoor Park Church of England Primary School.
2. The school is a voluntary aided school.
3. The name of the governing body is "The Temporary Governing Body of Monksmoor Park Church of England Primary School".
4. The Temporary Governing Body, since its inception on 17th January 2018 and until its conclusion on 31st October 2018, has consisted of:
 - a) 0 of 2 parent governors
 - b) 0 of 1 Local Authority governor
 - c) 0 of 1 staff governor
 - d) 1 Head Teacher
 - e) 7 of 7 foundation governors

From 1st November 2018 the Temporary Governing Body will be replaced by the Full Governing Body which will have the full complement of each category of governor as defined above.

5. Total number of governors is 12.
6. Foundation governors are appointed by Peterborough Diocese Board of Education.
7. Recognising its historic foundation, the school will preserve and develop its religious character in accordance with the principles of the Church of England, which includes respecting other faiths and in partnership with the church in the parish of Holy Cross, Daventry and at diocesan level.

The school aims to serve the community of Monksmoor Park by providing an education of the highest quality within the context of Christian belief and practice. It encourages an understanding of the meaning and significance of faith and promotes Christian values through the experience it offers to all its pupils.

8. The term of office for all governors, other than parent governors, is four years. The term of office for parent governors is one year.
9. The *Instrument of Government: Voluntary Aided Schools* came into effect on 17th January 2018.
